The footnotes may be used to elaborate or explain an argument in the text or to give additional information and should not be used for giving references/ citations.

Bibliography

The references to the works of authors shall be provided by using 'Parenthetical Citation' style. In this style, sources are briefly mentioned in the main body of the text in parentheses (brackets) and the full bibliographic information are provided at the end of the paper under the heading 'References'.
